Subject matter: Information provided by Casalgrande Padana S.p.A. pursuant to Article 13 of Legislative Decree 196/2003

Addressed to Professional architects and architectural Practices

Dear Sir or Madam,

Whereas

1) consequential to your participation in the International Architectural Competition called "**Grand Prix Casalgrande Padana**", following your visit to this site, the completion of our forms and initial contacts, our company will expect subsequently to collect and process your personal data;

2) For the sake of clarity we have set out the following definitions provided by Legislative Decree 196/2003:

Processing: Any operation, including when effected without the assistance of electronic equipment, relating to the collection, recording, organisation, conservation, consultation, elaboration, modification, selection, extraction, comparison, use, interconnection, blocking, communication, dissemination, deletion and destruction of data;

Personal data: any information relating to a natural individual who is identified or identifiable including indirectly, by means of reference to any other information including a personal identification number;

In all the above premises, pursuant to Article 13 of Legislative Decree 196/2003 (the Privacy Code),

We hereby inform you

That the collection and processing of personal data will be effected by this Company as follows:

- a) **General Purposes:** The data will be processed above all to ensure the correct management of all duties and formalities necessary to regulate the conduct of the competition described in the Recitals, to satisfy any requests you may have, to carry out bureaucratic formalities generally and compulsory business activities as laid down by law and in any case inherent to existing relations;
- b) **Promotional Purposes – the sending of a newsletter, publications and catalogues:** Your data (but not sensitive data) may be used, but solely and exclusively following your free, discretionary, specific and explicit consent thereto (which may be revoked at any time), for the sending to you of the periodical newsletter, publications and catalogues containing information and updating on the ceramics world, the main and newest market developments and similar subjects by e-mail and/or by paper through the post. After having given your consent you will in any case be entitled to refuse, without charge, to have your data processed for this purpose at any time;
- c) **The time over which the data will be retained:** your data will be retained by our Company in compliance with the maximum duration permitted by the law in force. Appropriate instructions will be given to those to whom your data may be communicated (please see further below), so that they too do not exceed the maximum retention times;
- d) **Procedure:** the data will be processed by both paper-based equipment and media as well as by electronic, computerised and telematic means in full compliance with the related law in accordance with principles of lawfulness and propriety and in such a way as to protect your confidentiality;
- e) **Discretionary consent:** The provision of your data is discretionary and not obligatory in nature;
- f) **The consequences of refusal:** If you refuse to provide the data or you oppose the processing of the same in full or in part for the purposes described under point a), this may mean it is impossible for you to participate in the competition referred to in the recitals and for you to receive a satisfactory response to any requests you may have. Your refusal to allow the use of the data for the purposes described under point b) however, will not have any consequences so far as participation in the competition or other relations are concerned;
- g) **The parties or categories of parties to whom your data may be communicated or disseminated:** Your data may solely and exclusively be communicated to a number of parties external to our business necessarily involved in the organisation, management and conduct of the competition for the correct performance of the purposes referred to under point a). These are, purely by way of non-exhaustive example, juries, advertising agencies, printers, posting bodies, consultants, associations etc. used by our Company. In no circumstances will your data be more generally disseminated;
- h) **Data Processors and specialist staff of the Company responsible for the processing:** Your data will be solely and exclusively processed by a restricted number of staff employed by the business in the administration, marketing, EDP and commercial sectors, all specifically authorised in that regard;
- i) **Rights of the Data subject:** As the data subject you will be entitled to all the rights set out in Article 7 of Legislative Decree 196/2003 to which you should refer for details;

j) **Data Controller:** The Data Controller of the processing is Casalgrande Padana S.p.A., with its Registered Office in Casalgrande (RE) at Via Statale 467, street no. 73, in the person of its Authorised Representative for the time being. The above information may be supplemented, whether orally or in writing with additional elements or indications to meet any further request for information you may have in relation to the privacy field and to match any changes in the related legislation.
